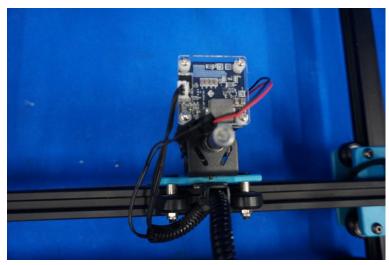


Overall view of the apparatus

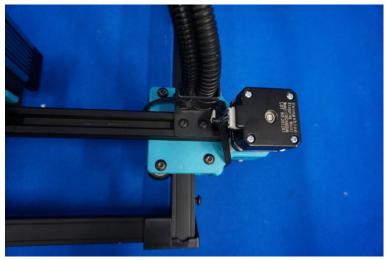

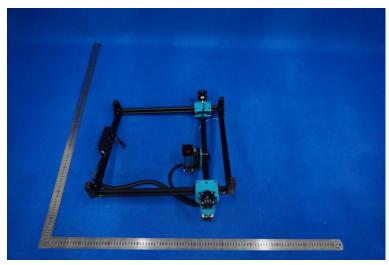
